The **Hellenic Financial Stability Fund ("Fund")**, is a Legal Entity of Private Law, established by Law 3864/2010. The Fund is headquartered in Athens and its duration is set to December 31st, 2022, with the possibility of renewal following a decision by the Minister of Finance.

We have a vacancy for a **Senior Risk Officer**. The right candidate will be selected upon the assessment of his/her qualifications and will be recruited under a private-law, fixed-term contract, renewable.

Role and Responsibilities

- Ability to develop job knowledge and expertise (theoretical and practical) through continuous professional development;
- Demonstrates an understanding of different organizational departments and functions.
- Analyses numerical data and all other sources of information, breaks them into component parts, patterns and relationships; probes for further information or greater understanding of a problem; makes rational judgments from the available information and analysis; demonstrates an understanding of how one issue may be a part of a much larger system.
- Takes responsibility for actions; takes initiative and works under own direction; initiates and generates activity and introduces changes into work processes.
- Assists in the smooth implementation of the internal timeline and follow up the deadlines assigned to collaborative peers
- Engages to continuous knowledge & development regarding regulations, best practices, tools and techniques.

- Bachelor's and postgraduate degree(s) from a Greek or foreign University in Economics, Banking, Finance or related fields
- Minimum eight (8) years of experience of which four (4) at mid-level managerial positions in the Banking sector or consulting/audit firm, with specialization in risk and capital management, NPL management and Banks' regulatory framework
- Strong experience in reviewing & analyzing Banks' risk & credit policies, financial & risk management reports, risk & capital strategies and NPL strategies, credit & restructuring proposals, key risk & performance indicators.
- Very good knowledge of Greek and European regulatory framework regarding the Banks' risk management, capital adequacy and NPL management & reporting (EBA/ECB/SSM).
- Excellent knowledge of MS Office (Excel, PowerPoint, Word)
- Excellent command of the English language (written and verbal), including financial/risk terminology.
